Resolution on abandoned, lost or otherwise discarded fishing gear

NEW - Par.2 "fishing gear is understood to mean fishing gear that poses a significant risk of ghost fishing when abandoned"

NEW - Measure only for fishing vessel exceeding 20 meters LOA

Deleted - Each CPC shall encourage that port operators provide adequate, accessible and affordable reception facilities for waste fishing gear.




Some changes

Par.11 In 2022 and 2023 a transitional fishing regime shall be established. CPCs shall ensure that national catch limits are established for small pelagics Par.11 In 2022 and 2023 a transitional fishing regime shall be established. CPCs shall ensure that national **or joint** catch limits are established for small pelagics

Par. 13 The CPCs with declared catches under 2500 tons in 2014 shall implement the same reductions as identified in paragraph 11 and for the period 2022-2023 catch limits are established in Annex I. For the CPCs with declared catches under 2500 tons in 2014, it is established a joint catch limit, where the same reductions as identified in paragraph 11 shall apply and for the period 2022-2023 catch limits are established in Annex I. CPCs, falling under the conditions of this paragraph, shall not exceed 70% of the total joint limit at any time.







Recommendation establishing a multiannual management plan for the sustainable exploitation of small pelagic stocks in the Adriatic Sea (GSAs 17 and 18)

Some changes

Par 49. CPCs shall monitor the consumption of the catch limit or total allowable catch quota [...]. As from the date when a 80% of quota has been exhausted, the CPC concerned shall communicate to GFCM monthly reports on catch. Such a report should be sent by the 10th

day of the month for the previous month. When the catch limit has been reached, CPC shall prohibit catch of small pelagics or individual species, taking into account paragraph 21.


- Such a report should be sent by the 15th day of the month for the previous month.
- In case of joint catch limits CPCs shall communicate to GFCM monthly reports on catch. Such a report should be sent by the 15th day of the month for the previous month.
- GFCM Secretariat, when 70% of the joint catch limit has been ex-hausted [...] CPC shall establish a fishing activities plan to avoid exceeding the jointly allocated catch limit [...]

Recommendation establishing a multiannual management plan for the sustainable exploitation of small pelagic stocks in the Adriatic Sea (GSAs 17 and 18)

Next STEPS relevant for MEDAC

- The plan should take account of the mixed nature of the fisheries and the nature of stock dynamics.
- A set of transitional precautionary management measures for the Adriatic Sea shall be developed in order to ensure that while minimizing socio-economic impacts and finalizing scientific advice by the SAC, the stocks and fisheries progress towards biologically sustainable levels.

→ In the first two years, with the possibility of a third transitional year

In 2022 and 2023, CPCs will fully engage to support and complete the sardine benchmark assessment and the **management strategy evaluation**



MEDAC will meet the provisional scientific results (STECF) on 17 December

The SAC, at its twenty-third session in 2022, shall give mandate to: the


- (1) WGSASP to complete a sardine benchmark in 2022 and
- (2) to the Workshop on the assessment of management measures (WKMSE) to carry out a management strategy evaluation in order to define the most appropriate harvest control rules for anchovy and sardine to be implemented according to paragraph 17 and 18.
- And Spatial and temporal closure and Fleet management measures

Par. 36 Based on the SAC advice, the GFCM may review the content of the MAP





Sub Regional Committee on Adiriatic Sea, including a Working Group on Management Strategy Evaluation session on small pelagic and demersal fisheries GFCM SRC-AS APRIL 2022 – MEDAC FG Adriatic



Perform an assessment of **alternative management scenarios** according to the general terms of reference [...], in particular in the context of the **management of small**

pelagic species and the five key demersal species covered by Recommendation GFCM/43/2019/5, including due consideration to the **participatory process**.

Launch a pilot project to underpin the biology and ecology of **bamboo coral in the Adriatic**, including a quantification of the interaction between Isidella and **bottom contact fisheries and the determination of their footprint**.





Implement the roadmap and **technical actions** to advance towards replying to the request of Rec. GFCM/43/2019/5 and the roadmap included in the recommendation to establish **additional FRAs** in the northern and southern Adriatic. CPCs, following a bottom up approach and while engaging with relevant stakeholders (Res. Roadmap).



Sub Regional Committee on Western Med, including a Working Group on Management Strategy Evaluation session on small pelagics, Blackspot Seabream and Common Dolphinfish fisheries GFCM SRC-WM APRIL 2022 – MEDAC FG WestMed

Continue to monitor **blackspot seabream** fisheries in Spain and in Morocco, [...] assessing the effectiveness of the measures in place, including their socio-economic impact



In 2022 GFCM shall adopt long-term measures

Perform an assessment of alternative management scenarios [...], in particular in the context of the management of **small pelagic species**, **blackspot seabream and common dolphinfish**

Continue providing support to the TRANSBORAN project for the analysis of stock boundaries of priority species in the subregion



Rec. FRA in the **Gulf of Lions** "The SAC (in 2023) shall evaluate the fishing effort regime and its reference period, the socio-economic and environmental impacts [...], including a **modification of the current closures, in time, geographical extension or gear-dependency**, taking into account fisheries characteristics, developments in the selectivity of the gear made, implementation of the European multiannual plan for demersal stocks"

Sub Regional Committee on Eastern Med, including a Working Group on Management Strategy Evaluation session on sardinella and deep-water red shrimp fisheries

Sustainable trawl fisheries targeting giant red shrimp and blue and red shrimp in the Levant and Ionian Sea "At its fortyfifth session (2022), the GFCM shall adopt long-term management measures"

Eastern Mediterranean

In the context of a research programme on NIS, continue efforts towards the assessment of priority NIS in the subregion

Eastern-central Mediterranean

In the context of deep-water red shrimp fisheries (Aristaeomorpha foliacea and Aristeus antennatus), carry out technical activities proposed by the SAC to provide advice on potential management measures, including the implementation of a research programme, work of the interaction between VMEs and the DWRS fishery and the implementation of a pilot project towards the establishment of a catch certification scheme.





European Union

Sub Regional Committee on Central Med, including a Working Group on demersal, common dolphinfish and deep-water red shrimp fisheries GFCM SRC-CM MAY 2022 - MEDAC FG Strait of Sicily



Sustainable trawl fisheries targeting giant red shrimp and blue and red shrimp in the Strait of Sicily "At its forty-fifth session (2022), the GFCM shall adopt long-term management measures"

Bottom trawl fisheries exploiting demersal stocks in the Strait of Sicily towards the implementation of a long-term multiannual management plan implementation of a large-scale multiannual pilot study on the selectivity

Central Mediterranean

In the context of demersal fisheries in the central Mediterranean (European hake and deep-water rose shrimp), carry out technical activities proposed by the SAC to provide advice on potential management measures, including potential FRAs.

Western-Central Mediterranean

Common dolphinfish is a priority species in both the western and central Mediterranean, targeted by a specific small-scale fishery assisted by fish aggregating devices (FADs)

A GFCM WG shall be established in 2022 in order to develop a **multiannual management plan** for common dolphinfish fisheries that comprises measures for the management of FADs, considering socio-economic elements www.med-ac.eu
